CALL FOR 2025/2026 PROGRAMME/PROJECTS APPLICATIONS FOR FUNDING BY THE NORTH WEST PROVINCIAL DEPARTMENT OF AGRICULTURE AND RURAL DEVELOPMENT (DARD) TOGETHER WITH THE NATIONAL DEPARTMENT OF AGRICULTURE.

The North West Department of Agriculture and Rural Development (DARD), together with National Department of Agriculture calls for 2025/2026 financial year funding applications for CASP and Ilima/Letsema conditional grants. Funding will be based on two departmental prioritized programmes, namely: Animal Husbandry and Arable Farming. Funding consideration will be based on commodity value chain.

Target Farmer Categories:

1. Subsistence
2. Smallholder
3. Commercial

Type of Support:

1. On and off farm infrastructure
2. Production inputs
3. Enterprise and Business Development
4. Farmer Training; Skills development & Capacity building

Minimum Requirements:

1. Applicants should demonstrate keenness to farm and run a profitable business
2. Applicants should be registered on the Provincial farmer database by closing date
3. Valid confirmation of access to land (Title deed; Stamped & signed Tribal Resolution; Permission to Occupy, Minimum 5 years Lease Agreement)
4. Proof of access to water for irrigation projects i.e. fruits, vegetables and other irrigated crops (water license/rights).
5. Proof of Water/waste license for Piggery and Poultry.
6. Business Plan
7. Proof of access to market (Off-take agreements, letters of intent, etc.)
8. Farming operation should be able to create permanent and/ or temporary jobs
9. Where necessary, evidence of relevant commodity authorisations to be provided (environmental impact assessments, virgin land plough certificates, Aquaculture & Fishing permits, etc.)
10. Application form completed in full
11. Certified South African ID copy; not older than 3 months.
12. Applicants should not be Government Employees or Political office bearers

Priority will be given to the following:

- Historically disadvantaged individuals
- Vulnerable groups (Youth, Women and People With Disabilities)
- Producers farming in the Cotton commodity
- Producers farming in the Citrus commodity
- Farming and/or agricultural enterprises that are in line with and feed into the Agriculture and Agro-processing Masterplan (AAMP)
- Farming and/or agricultural enterprises that are involved in Agricultural value chain production
- Applicants who have never been supported by an organ of State before (This excludes incomplete projects and multi-year projects)

Application forms are obtainable from Local Agricultural Offices (LAOs) and the departmental website. All application forms should be submitted directly to the Local Agricultural Offices on or before **31 AUGUST 2024**. Applicants will be given a reference number upon receipt/submission of the application. Please **note that no late, faxed, or emailed applications will be accepted**. The Department reserves the right to consider any application. **The applicant/s gives DARD permission to process their Personal Information, once they have signed and submitted their application form.** Successful applicants will be required to enter into funding agreement with the department. **Should you not receive any correspondence from the Department within 3 months of application, please consider your application unsuccessful and visit your Local Agricultural Office for any further informati**
